### Terms and Conditions for Subscription of Google Workspace Account (Free Trial)

提交本申請書，即表示您明白並同意這裡的訂閱 Google Workspace 帳戶條款和細則（免費試用）。

By submitting this Application, you understand and agree to the terms and conditions for subscription of Google Workspace Account (Free Trial) herein.

您同意委任 Hong Kong Telecommunications (HKT) Limited（“HKT”）作為您的代理人，以協助您申請訂閱 Google Workspace 帳戶相關的任何事宜。HKT 將協助您訂閱 Google Workspace 帳戶，並由 HKT 自行決定提供相關的客戶服務（統稱為“服務”）。

You agree to appoint Hong Kong Telecommunications (HKT) Limited ("HKT") as your agent to facilitate any matters in relation to your application for subscription of Google Workspace account. In consideration of your appointment, HKT will facilitate your subscription of Google Workspace account and provide relevant customer support in HKT's sole discretion (collectively, "Services").

您的 Google Workspace 免費試用帳戶只適用於 Google Workspace Business Starter、Business Standard 或 Business Plus 版。Google Workspace 帳戶相關的域名將免費提供給您。您的 Google Workspace 帳戶最多只能支援 20 個用戶，並享有 21 天的免費試用期。

All files as well as the domain provided in association with your Google Workspace account will be deleted permanently in 30 days upon the end of the free trial period and no recovery can be done thereafter, unless you subscribe the Business Starter, Business Standard or Business Plus version of Google Workspace from HKT during the free trial period to continue the use of your Google Workspace account, provided that no downgraded version can be purchased and the number of End User accounts cannot be reduced. If you make such purchase, the free trial period will be ended instantly and the remaining days of the trial period will be absolutely forfeited.
